THIS NOTIFICATION WILL BE DONE FOR THE PURPOSE OF ALLOWING MANAGEMENT TO RECEIVE THE UNIONS' VIEWS CONCERNING THE CHANGE BEFORE IMPLEMENTATION.

The LAMPS Team mutually agree, based on the above, to consider this case formally closed, effective with the signing of this settlement.
